Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 24 of which not more than 1/3rd sections shall be used for senior secondary classes. Number of students shall be restricted to 32 in 21 sections. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 ft dimension
2	The school has constructed a ramp to access the upper floors, but it is very steep and cannot be easily navigable by a wheelchair-bound student/staff, the school is required to re-construct the ramp or install the lift to access upper all the floor with

	the provision laid in RPWD Act and board's guidelines, within 03 months and submit the compliance.
3	The school is required to construct the separated CwSN toilets for Girls /boys on each floor with proper permanent signage, indicating the floor numbers as per norms of RPwD Act and board's guidelines, within 03 months and submit the compliance.
4	The school is directed to pay the salary to its staff through ECS mode only and submit the banker certificate, certifying that the salary is being paid by the school through ECS mode within months in the compliance.
5	The school is required to upgrade the composite science lab without proper seating (wooden stool) and storage facilities and per Board's Sop within 03 month and submit the compliance.
6	The school is required to make a separate reading space in the library for its staff within 03 months and submit the compliance.
7	The school is required to clean the playground and upgrade sufficient outdoor game facilities.
8	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
